

SITE RULES LEISURE CONTRACT CAMPING LE CLOS DU BLAVET

1. GENERAL CONDITIONS

1. Conditions of Admission and Stay

In order to enter onto the site, to set up or to stay you must first have the permission of the manager or his representative. The management is obliged to ensure that the site is maintained in good order and that the site rules are respected. Admission onto the site means that you agree to abide by the site rules.

No one can elect to be domiciled there.

2. Police Formalities

Unaccompanied minors will only be admitted with the written authorisation of their parents.

Under article R.611-35 of the code of entry and residence of foreigners and of the right of asylum, the manager is required to complete and get signed by all clients of foreign nationality, on their arrival, an individual police form. Mentioning notably:

1. Surname and first names
2. Date and place of birth
3. Nationality
4. Permanent residential address

Children under the age of 15 can be included on the form of one of their parents.

3. Installation

Outdoor accommodation and related equipment must be set up in the designated pitches and conform to the instructions of the manager or his representative.

4. Reception Office

Open from 10.00am to mid-day and from 4.00pm to 6.00pm in low season and from 9.30am to 12.15 and from 3.30pm to 7.00pm in high season.

In the reception office you will find all the information on the site services, information on the provision of fresh supplies, the sports facilities, tourist information and miscellaneous addresses which may be useful.

A complaints procedure is available to all clients.

5. Notices

The current site rules are displayed at the entrance to the site and at the reception office. The rules will be given to clients should they demand it.

For the designated camping areas, the classification category of either tourism or leisure and the number of each are shown.

The prices of the different offerings are communicated to clients under conditions fixed by the minister responsible and are available to consult at the reception office.

6. Departure

Please notify the reception office the day before your planned departure. The clients planning to leave before the opening of the reception office must settle their account the day before.

7. Noise and Silence

All users of the site must avoid all noises which could upset their neighbours. Any sound apparatus (e.g. radios TVs etc.) must be consequently suitably regulated. Doors and car boots should be closed as discreetly as possible.

Dogs and other animals must never be loose on the site. They must not be left alone on the site or in the caravan or tent without their masters who are civilly responsible for them.

The management ensures the peace of his clients by fixing the hours during which total silence is required. Complete silence is between 10.30pm and 7.45am.

8. Visitors

After having been authorised by the manager or his representative, visitors may be permitted onto the site under the responsibility of the client who has invited them.

Clients can receive one or more visitors at the reception office. Site facilities are available to visitors. However, the use of these facilities is payable according to the tariff which is displayed on a notice at the entrance to the site and at the reception office.

Visitor's vehicles are not permitted on the site.

9. Traffic and Vehicle Parking

Inside the site, vehicles must not exceed the speed limit of 10 km/hr and must follow the direction of traffic as indicated.

Driving is authorised between 7.45am and 10.30pm.

Only vehicles belonging to the campers staying on the site may be driven on the site. Parking must be on the designated pitch. Parking must not hinder the traffic flow nor prevent the installation of new arrivals.

Leisure Contract: Only one vehicle per pitch.

10. Appearance of the installations

Everyone must abstain from any action which could be harmful to the cleanliness and hygiene of the site and its installations.

It is forbidden to throw used water on the ground.

Clients must empty their used water in the installations provided for the purpose.

Household waste, paper and rubbish of all kinds must be disposed of in the bins located at the exterior of the site "tri-sélectifs"

The hanging out of washing to dry, should this be necessary, must only be on the communal line provided. However, it is possible close to the caravan/tent on the condition that it is very discrete and that it doesn't cause upset to the neighbours. Washing must never be hung from the trees.

The plants and floral decorations must be respected. Clients are forbidden from putting nails in the trees, from cutting branches or planting shrubs. It is not permitted to create boundaries around a pitch by personal means, nor to dig in the ground.

Any damage to the vegetation, fencing, land or installations will be charged for.

The individual pitch which has been used during the stay must be maintained and left in the same state in which it was found on arrival.

Leisure Contract: Clients are asked not to use the sanitary blocks. These are reserved for campers.

11. Safety

- (a) Fire: Open fires (wood, charcoal etc.) are strictly forbidden. Camping gas stoves must be maintained in good condition and not be used in dangerous conditions.
In the case of fire inform the management immediately. Fire extinguishers are available if required.
A first aid kit is available in the reception office.

Leisure Contract: Owners are asked to take great care when using their barbecues. (Charcoal barbecues are forbidden).

- (b) Theft: The management is responsible for all objects deposited in the reception office and has a general obligation to monitor the site. Clients are responsible for their own installations and must notify the manager or his representative of the presence of any suspicious activity. Clients are advised to take the usual precautions to protect their belongings.

12. Games

No violent or annoying games may be organised in close proximity to the installations.

The social hall cannot be used for lively games.

Children must be under the supervision of their parents at all times.

13. Immobilised Parking

Unoccupied cars, caravans, tents etc. may only be left on the site with the agreement of the management and only in the areas indicated. A fee is payable for this facility.
